James Douglas was appointed to the Supreme Court of Queensland in 2003. A barrister from 1973, he took silk in 1989 and was President of the Bar Association of Queensland from 1999 to 2001. He was editor of the Queensland Reports from 1986 to 1991 and a member of the Legal Committee of the Companies and Securities Advisory Committee from 1992 to 1994. He is also a member of the American Law Institute, the body responsible for producing the Restatements of American Law, was a part-time member of the Anti-Discrimination Tribunal during 2003 and a Grade 1 arbitrator through the Institute of Arbitrators and Mediators of Australia. From 1990 to 1996 he was Chairman of the Queensland Theatre Company and from 1989 to 1996 Chairman of the Queensland Symphony Orchestra's Advisory Board.

Ian Freckleton SC is a Melbourne barrister who took silk in 2007. He has a largely appellate practice. His main areas are criminal, personal injury

and administrative law. He has held a number of tribunal and adjunct academic appointments. He is currently an Honorary Professor of Law, Forensic Psychology and Forensic Medicine at Monash University. He was appointed a Deputy President of the Australian Conciliation and Arbitration Commission in 1975. He served as first Chairman of the Australian Law Reform Commission from 1975 to 1984. In 1983 he became a judge of the Federal Court of Australia, serving on that Court until 1984.

Margaret McMurdo AC is the President, Court of Appeal, Supreme Court of Queensland. Appointed in 1998, formerly barrister, assistant public defender, Judge of the District Court and Children's Court Judge. She was president, Women Lawyers' Association of Queensland in 1980-1981, a member of the Litigation Reform Commission – Criminal Procedure Division, 1992-1994, has been a member of the QUT Faculty of Law Advisory Committee since 1991, and is a member of the Griffith University Council. She was awarded the Centenary Medal in 2003.

Hugh Selby is a one time barrister now engaged in teaching and writing. His particular interests are advocacy, expert witnesses, and litigation issues. He was once a statutory office holder and has worked in several public services, and for a trade union.
