# HOMOPHOBIA: TOWARDS AN AUSTRALIAN HISTORY

Early one December morning in 2007, after spending an evening at a local nightclub, Craig Gee and his partner Shane Brennan walked along Sydney's Crown Street. They held hands, feeling secure in doing so. Both men were local residents familiar with the area. Crown Street is located only blocks away from Oxford Street, an area known to many as Sydney's 'golden gay mile'. This walk home though, turned out very differently to any other. Four men set upon them suddenly, yelling 'Give us your money you fucking faggots'. In the vicious physical attack that followed, both Craig and Shane were seriously wounded. Craig was particularly severely injured. One of the assailants stamped on his face, breaking his eye socket in three places and reducing part of his skull to powder. One of his legs was also broken. He has since had to undergo reconstructive facial surgery and cannot remember the assault. Shane was left with a feeling of helplessness, both as a result of the violence, and the ensuing trauma of witnessing his partner's difficult recovery. The physical impact of the attack was compounded four days later, when one of the assailants used Craig's stolen phone to call his mother, telling her 'We killed your faggot son'.<sup>1</sup>

In the aftermath of the attack, Craig and Shane attempted to report the violence at the Surry Hills police station, but found that the police discouraged them from making a formal statement. Craig believed that the police were reluctant to investigate any leads or to use any security camera footage that may have taped the attack.<sup>2</sup> Since the bashing, Craig has suffered nightmares,

and reinforce control and mastery over others. It diverts energy away from more constructive endeavours.<sup>42</sup>

The Australian GLTBIQ community has made significant strides towards equality over the past 30 years. Recent polls have shown that increasing numbers of Australians view homophobia as a destructive blight on our social fabric. If this prejudice is to be eradicated, a full awareness of its historic development and expression is necessary. It is hoped that the current collection can aid in developing such an awareness, and by demonstrating the historical extent of homophobia and the impact of anti-homosexual beliefs, perhaps contribute to a more tolerant and open attitude towards sexual difference. Moreover, as homophobia often tends to be linked to sexism, it is hoped that this collection may also be useful in providing some new insight into the historical development and expression of this prejudice.<sup>43</sup>
