Professor Michael Coper was from 1998 to 2012 Dean of the ANU College of Law at the Australian National University, where he is currently Professor Emeritus. He is the author of a number of books on Australian constitutional law, including *Freedom of Interstate Trade Under the Australian Constitution* (Butterworths, 1983) and *Encounters with the Australian Constitution* (CCH, 1987), as well as co-editor of *The Oxford Companion to the High Court of Australia* (OUP, 2001). Shortly after the decision in the *Tasmanian Dam Case*, he published a comprehensive commentary on the case in *The Franklin Dam Case* (Butterworths, 1983).

Dr Heather Roberts is a Senior Lecturer at the ANU College of Law at the Australian National University where she teaches constitutional law and property law. Her PhD explored the constitutional philosophy of Justice Deane, a member of the High Court of Australia in the *Tasmanian Dam Case*, and she has since published studies of the constitutional philosophies of Justices Deane, Kirby and Heydon. Heather's current research examines the role of judicial swearing-in ceremonies in telling the history of Australia's courts and the biography of its judges, with a particular focus on how these rituals illuminate the history of Australian women lawyers. Heather has also served as ACT Chapter Chair and National Secretary of the Australian Association of Constitutional Law.

Professor James Stellios is the Director of the ANU's Centre for International and Public Law. His primary research interest is constitutional law, and he has published widely in that field, including *The Federal Judicature: Chapter III of the Constitution* (LexisNexis, 2010) and the sixth edition of Professor Leslie Zines's classic work, *The High Court and the Constitution* (Federation Press, 2015). He is also a barrister at the NSW Bar and has appeared as junior counsel in a number of High Court and lower court cases.

More generally, he has been an adviser to successive Australian Governments on international law. He has been Agent and/or Counsel for Australia in a number of cases before the International Court of Justice and international tribunals, including *Whaling in the Antarctic*, *Questions Relating to the Seizure and the Detention of Certain Documents and Data*, the *Southern Bluefin Tuna* Cases and the Tobacco Plain Packaging Arbitration (*Philip Morris (Asia) v Australia*).

Professor Rosalind Dixon is a Professor of Law at the University of New South Wales, Faculty of Law. Her work focuses on comparative constitutional law and constitutional design, theories of constitutional dialogue and amendment, socio-economic rights and constitutional law and gender. She is a member of the Gilbert + Tobin Centre of Public Law and Deputy Director of the Herbert Smith Freehills Initiative on Law and Economics. She previously served as an Assistant Professor at the University of Chicago Law School.

Professor Mick Dodson AM is Director of the National Centre for Indigenous Studies at the Australian National University and Professor of Law at the ANU College of Law. He has been a prominent advocate on land rights and other issues affecting Aboriginal and Torres Strait Islander peoples. He served for six years as a member of the United Nations Permanent Forum on Indigenous Issues. In 2009, he was named Australian of the Year by the National Australia Day Council, and in 2011-12 was the Malcolm Fraser & Gough Whitlam Harvard Chair in Australian Studies.

The Hon Gareth Evans AC QC is Chancellor and Honorary Professorial Fellow at the Australian National University, and President Emeritus of the International Crisis Group, which he led from 2000-09. After teaching constitutional law at Melbourne University from 1971-76, and practising as a barrister, he was a member of the Australian Parliament for 21 years, and a Cabinet Minister in the Hawke and Keating Governments for 13 years, including as Attorney-General in 1983-84, and Foreign Minister from 1988-96.

Alison Hammond is a solicitor practising in litigation and dispute resolution at King & Wood Mallesons in Sydney. In 2015, she was an Associate to the Hon Justice Virginia Bell at the High Court of Australia. Alison holds undergraduate degrees in Arts and Law (First Class Honours) from the University of Sydney and a postgraduate Bachelor of Civil Law (Dist) from the University of Oxford. She has also taught in the ANU College of Law at the Australian National University. Alison has diverse academic interests across civil procedure, contractual and corporate disputes, public law and legal history.

Dr Siobhan McDonnell is a lawyer, economist and anthropologist with 18 years' experience working on legal and policy issues with Indigenous people in Australia and Melanesia. She is currently a Research Fellow at the National Centre for Indigenous Studies and also a convenor and lecturer in Pacific Studies at the Australian National University. Siobhan has a PhD in Legal Anthropology and specialises in Indigenous land rights and governance issues, with a particular interest in the recognition of customary law and legal pluralism. In 2014, she was the principal drafter of a new set of land laws in Vanuatu, as well as amendments to the Vanuatu Constitution. In 2015, Siobhan worked on land reform with the Solomon Islands Government.

Professor Andrew Macintosh is Associate Dean (Research) at the ANU College of Law at the Australian National University. His area of expertise is environmental law and policy, particularly climate change mitigation and adaptation, and environmental impact assessment and approval processes. He has published widely in these fields and served on several government committees, including as Chair of the Australian Government's Emission Reduction Assurance Committee and Domestic Offsets Integrity Committee, and as Associate Member of the Climate Change Authority. He is also a member of the ANU Centre for Climate Economics and Policy, ANU Climate Change Institute and ANU Energy Change Institute.

The Hon Sir Anthony Mason AC KBE GBM was a Justice of the High Court of Australia from 1972 to 1987 and Chief Justice from 1987 to 1995. He was Commonwealth Solicitor General from 1964 to 1969 and a Judge of the NSW Court of Appeal from 1969 to 1972. He has been Chancellor of the University of New South Wales, National Fellow at the Research School of Social Sciences at the Australian National University, a Judge of the Supreme Court of Fiji and President of the Solomon Islands Court of Appeal. In 1996-97, he was Arthur Goodhart Professor in Legal Science at Cambridge University. Since 2001, he has been Distinguished Visiting Fellow at the ANU College of Law at the Australian National University.

Sir Anthony was a non-permanent Judge of the Hong Kong Court of Final Appeal from 1997 until 2015. In July 2013, the Hong Kong Government awarded him the Grand Bauhinia Medal (GBM), Hong Kong's highest honour.

Professor Donald R Rothwell has since July 2006 been Professor of International Law at the ANU College of Law at the Australian National University. His research has a specific focus on law of the sea, law of the polar regions, and implementation of international law within Australia. Rothwell has authored, co-authored or edited 22 books, including most recently *International Law in Australia* (Thomson Reuters, 3rd ed, 2017), co-edited with Emily Crawford. He is also co-editor of the *Australian Year Book of International Law*, and since 2012 has been Rapporteur of the International Law Association (ILA) Committee on 'Baselines under the International Law of the Sea'.

Professor Anne Twomey is a Professor of Constitutional Law and Director of the Constitutional Reform Unit at the University of Sydney. She has previously worked for the High Court, the Senate Legal and Constitutional Committee and the Cabinet Office of New South Wales. Her publications include works on State Constitutions and vice-regal powers.
