

According to Kreissman, "Kohl's concept is a model of simplicity. From 34 core library journals, he has isolated the central findings of each of the research articles published since 1960 (research interpreted here to include surveys and similar information gathering techniques). He has grouped the isolated selections into well-chosen topical categories and then arranged the findings by type of library (public, academic, school, special) and date. He provides a succinct summary of each and every research finding. He completes the work with an array of indexes..."



You'll locate directly relevant information within minutes . . .

Each Handbook is designed to solve a basic problem that plagues library managers and decision makers: They need information to help them with complex management issues, but they can't devote the time to involved literature searches necessary to generate specific, applicable answers. The work is organized by basic subject area, further divided into library type, leading the user to helpful, directly relevant information within minutes. Digests are informative, conveying the significant contents of the original. This feature is of particular benefit in smaller libraries where the original formats may not be available. Chronological arrangement of digests within each subject area adds a historical dimension to the findings, letting the user track developments in certain areas, such as disparities in salaries paid to men and women, or basic concepts of circulation, or design of study carrels.

Each of the six volumes covers two or more of 16 basic subjects in administrative and management practices. Whatever the subject, the user can turn immediately to the appropriate volume and can quickly locate the information needed, since the format in each volume follows the same basic pattern: An introduction, a list of journals surveyed, a detailed table of contents listing all subject headings, research findings arranged by subject, a bibliography of articles surveyed, and an alphabetical author index to the articles. Each volume features a Foreword by a distinguished librarian.

McCalman, describes the life and times of the Prahran Mechanics' Institute and Circulating Library — born 1854 and still going strong. Now developing a Victorian and local history collection, and with a professional librarian to boot! Pioneer and hardy survivor costs \$2.50 plus 55c postage. The Mechanics' is at 140 High Street, Windsor 3181.

Dictionary of literary biography: volume 22: American writers for children 1900-1960 (ISBN 0 8103 1146 1) from Gale, edited by John Cech. Covers 43 writers of that ilk, including the authors of The Wizard of Oz, Madeline, Raggedy Anne, Little house on the prairie and The little engine that could. Welledited, bite-size chunks, copiously illustrated, informative. Includes our very own Hugh Crago on the d'Aulaires. Published in 1983 by Gale and well up to standard. US\$82.00.
