Launch of LawCite - AustLII's free-access international citator

The Hon. Justice Michael Kirby launched LawCite at AustLII's end of year reception in December 2008. Over 60 representatives from the legal profession, publishers, courts and tribunals, business, government and the education sector attended the launch. LawCite is AustLII's new international free-access citator and includes references to decisions and articles citing a particular case. English Reports back to the 13th century on CommonLII

The English Reports from 1220-1873 are available for the first time for free access. Justis Publishing has provided the data to AustLII in a collaborative arrangement. The original image of the decision is provided and the text is searchable.

To the right is a screen shot of Bushell's case (the famous jury case) decided in 1670 by Sir John Vaughan, Chief Justice of the Court of Common Pleas and published in the English Reports in 1823, one of 124,882 old English decisions searchable on CommonLII (www.commonlii.org).

As well as publishing decisions from earlier centuries, AustLII publishes 21st century decisions as rapidly as technology permits. For example, decisions handed down by the High Court are on AustLII's website within 30 minutes of the decision being released.

First AsianLII conference

From 24-25 February 2009, 80 delegates from across Asia and the Pacific attended the first AsianLII conference in Sydney to share experiences and ideas on the legal, technical and business aspects affecting the provision of free-access legal information online. Highlights of the conference included an opening address by the Attorney General, the Hon. Robert McClelland, presentations from prominent Australian Chief Justices and international speakers from Asia and Pacific judicial bodies, universities and legal information institutes. The conference program and presentations are accessible from the AsianLII website at: www.asianlii.org. AustLII operates AsianLII providing free access to legal information from 28 Asian countries. It began operations in 2006 with funding from the Australian Research Council. AusAID and the Cth Attorney-General's Department now primarily fund AsianLII.
