There are four search options within the Library:

Conduct your search over specific tax law databases on AustLII and tax treaties and journals.

Enables searching of Australian search engine.

Enables users to search the ATO legal database using AustLII's interface.

The Library is unique in that it brings together all related legal materials in a single searchable form and is updated daily automatically.

Professor Graham Greenleaf demonstrated the Library at the 22nd Australasian Tax Teachers Association Conference 2010 in January.

Almost half of Western Australia's barristers attended AustLII's presentation on "free-access online legal research for busy practitioners" in February. The WA Bar was introduced to LawCite, AustLII's free-access international citator and garnered new tips and techniques to more effectively search AustLII. AustLII has been providing free-access to law for 15 years in 2010.

Did you know these search tips?

1. Search terms can be accompanied by several sophisticated operators to focus your search. The operators that can be used in AustLII's search are outlined in the Search Operators Chart:

www.austlii.edu.au/austlii/help/operators.html

2. Common words, such as 'the, all, but, what, he' etc are not indexed therefore cannot generally be searched. However, if you would like to include a common word, prefix it with a '+' or '#' symbol. For example, '#the common law'.

3. AustLII has extensive Help sections on searching for legislation, cases, LawCite, secondary materials and FAQs. Visit [Help] at the top right of AustLII's home page.

International law library

AustLII received grant funding from the Australian Research Council and industry partners to build the world's most comprehensive free-access online International Law Library.

The International Law Library is hosted on WorldLII, which AustLII operates. Existing databases have been updated and 23 new databases have been added, effectively doubling the number of documents available.
